## IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

**AN ORDINANCE** repealing sections 5400. and 5410., <u>Jackson County Code</u>, 1984, relating to the building code, and enacting, in lieu thereof, two new sections relating to the same subject.

**ORDINANCE NO. 5765,** July 10, 2023

**INTRODUCED BY** Jeanie Lauer, County Legislator

WHEREAS, the permitting of safe and secure buildings is an important responsibility of County government; and,

WHEREAS, the County adopted chapter 54 of the County Code, the Building Code, in 1992 and

adopted subsequent versions incorporating the 2009 International Building Code as the most current version, with various appendices relating to electrical, plumbing, fire, and other assorted standards and guidelines; and,

WHEREAS, most jurisdictions within the Kansas City metropolitan area have adopted the 2018 International Building Code; and,

WHEREAS, to ensure the construction of safe and secure buildings throughout the unincorporated area of the County, it is in the best interests of the public health and welfare of the citizens of Jackson County to modernize the building code to a level equal to that of the surrounding jurisdictions and to update fees for the County's services; now therefore,

BE IT ORDAINED by the Legislature of Jackson County, Missouri, as follows:

### Section A. Enacting Clause

Sections 5400. and 5410., <u>Jackson County Code</u>, 1984, are hereby repealed, and two new sections in lieu thereof, to be known as sections 5400. and 5410., to read as follows:

### 5400. Building Code.

#### Referenced Codes:

Any and all references to the International Electrical Code shall reference the National Electrical Code.

Any and all references to the International Plumbing Code shall reference the Uniform Plumbing Code.

As said publications may be amended, are adopted as the code of Jackson County for regulating the erection, construction, occupancy, equipment, use, height, area, and maintenance of all buildings or structures in the unincorporated area of Jackson County and on all Jackson County-owned real property, without regard to its location within the County. Each and all of the regulations, provisions, conditions, and terms of such International Building Codes, [2009] 2018 Edition, and International Code Council, published by the International Code Council, and the secondary publications referenced above, as said publications may be amended, all of which are on file in the office of the director of public works, are referred to, adopted, and made a part hereof as if fully set out in this section.

### 5410. Fees.

No permit shall be issued pursuant to section 5409. of this chapter until the applicant therefor has paid the fee specified in this section, to include a plan review fee if applicable, based on the fair market value of the proposed improvement for which the permit is sought as established by the most current building valuation data as set forth in the International Conference of Building Officials Standard Publication:

Agricultural-use pole barns valued at \$20,000.00 or less are exempt from the above valuation chart. These structures shall be assessed a flat fee of \$125.00. Agricultural-use pole barns valued at \$20,000.00 up to \$40,000.00 will be assessed a flat fee of \$300.00. All barns valued above \$40,000.00 will be assessed a fee consistent with the Building Permit Fees Schedule contained in this section. When the building official has determined that unauthorized work, as defined in the International Building Code, has been performed without first obtaining proper permits, permit fees shall be double the normal fee.

Effective Date: This ordinance shall be effective immediately upon its signature by the County Executive.
