BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that pursuant to Chapter 28, Jackson County Code, 1984, the Director of the Department of Finance is authorized to issue a check in the amount of \$12,298.00 to the City of Sugar Creek for use in the City's 1997 street and road maintenance program.
