WHEREAS, Guadalupe Center, Inc., has received a grant from the Heart of America United Way for this program, in the amount of \$30,858.00; and,

WHEREAS, the Prosecuting Attorney has reviewed this proposal and recommends the expenditure

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive
is hereby authorized to execute an Agreement with the Guadalupe Center, Inc., for its El Otro Camino
program, in a form to be approved by the County Counselor; and,
BE IT FURTHER RESOLVED that the Director of the Department of Finance is hereby authorized to
make all payments, including final payment on the Agreement.
