be and hereby is authorized to execute a Cooperative Agreement with ArtsTech, for the Prosecutor=s				
Office MyARTS Program, in a form to be approved by the County Counselor; and,				
BE IT FURTHER RESOLVED that the Director of Finance and Purchasing be and hereby is				
authorized to make all payments, including final payment on the agreement.
