WHEREAS, by Ordinance 5002, dated August 14, 2017, the Legislature did authorize the

acceptance of funds for the Family Court Division's Juvenile Court Diversion Program grant, in the

amount of \$292,967.00; and,

WHEREAS, the State of Missouri Division of Youth Services has authorized additional funds for this

grant in the amount of \$150,000.00 and an amendment to the scope of services to include the Parenting with Love and Limits Project; and,

WHEREAS, the Parenting with Love and Limits Project will combine parent education and group therapy programs with individual coaching session for adolescents and their parents; and,

WHEREAS, the grant amendment does not require local matching funds; and,

WHEREAS, an appropriation is necessary to place the grant funds in the proper spending accounts; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation be made from the undesignated fund balance of the 2017 Grant Fund:
