AN ORDINANCE approving a conditional use permit for the operation of a private airfield, as to a certain 4.2 + acre tract. ORDINANCE 2766, December 8, 1997

INTRODUCED BY Dennis Waits, County Legislator

BE IT ORDAINED by the County Legislature of Jackson County, Missouri as follows:

Section 1. A conditional use permit for twenty years for the operation of a private airfield, subject to the restrictions specified on the attached Request for Legislative Action, under the Unified Development Code, is hereby approved as to a certain tract of land described as follows:

Description: The 4.2ñ acres is a part of a larger tract approximately one-half(«) mile east, on the north side of Blue Valley Road lying in the southeast 1/4 of Section 24, Range 31, Township 51 in Jackson County, Missouri beginning 660 feet more or less north of the southeast corner of Section 24; thence north along said section line 80 feet; thence west 2,300 feet; thence south 80 feet; thence east 2,300 feet to Point of beginning, aka 25204 E. Blue Valley Road.

Section 2. The Legislature, pursuant to the application of Carl Martens, (CU-97-029), requesting approval embodied in this ordinance and with notice that the Jackson County Planning Commission unanimously recommended approval of this application in a public hearing on November 20, 1997, does adopt this ordinance pursuant to the Jackson County Charter authorizing the Legislature to exercise legislative power pertaining to planning and zoning...Attorney

Effective Date: This Ordinance shall be effective immediately upon its signature by the County Executive.
