WHEREAS, the County and the Mid-America Regional Council (MARC) desire to enter into a Cooperative Agreement, a copy of which is attached hereto and incorporated by reference herein, whereunder the County will pay MARC \$30,000.00 to provide assistance to low-income families; and,

WHEREAS, under the Agreement, MARC is authorized to subcontract with the Bishop Sullivan Center in an amount not to exceed \$30,000.00 to fund the Bishop Sullivan Center which assists low-income families; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the Agreement is hereby approved and that the County Executive is authorized to execute the Agreement on behalf of the County; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make all payments, including final payment on the Agreement...Attorney

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
