## IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

**AN ORDINANCE** amending the zoning districts established pursuant to the Unified Development Code by changing a certain 1.05 ± acres tract from District A (Agricultural) to District RS (Residential Suburban).

**ORDINANCE #4446**, September 10, 2012

BE IT ORDAINED by the County Legislature of Jackson County, Missouri as follows:

<u>Section 1</u>. The Zoning Order of Jackson County, Missouri, and the official maps which are a part thereof, are amended by changing the boundaries of the "A" (Agricultural) District, and the "RS" (Residential Suburban) District, so that there will be transferred from District A to District RS, a tract of land described as follows:

**Description:** Lot 30, Trophy Estates, a subdivision in Jackson County, Missouri.

<u>Section 2</u>. The Legislature, pursuant to the application of Tim D. and Sara J. Mathes (RZ-2012-484), requesting the amendment embodied in this Ordinance and with notice that the Jackson County Plan Commission voted 7 to 0 to recommend <u>APPROVAL</u> of this application after a public hearing on August 16, 2012, does adopt this Ordinance pursuant to the Jackson County Charter authorizing the Legislature to exercise legislative power pertaining to planning and zoning.

Effective Date: This Ordinance shall be effective immediately upon its signature by the County Executive.
