INTRODUCED BY Victor E. Callahan, County Legislator

WHEREAS, the term of the Reverend Nelson Thompson, a member of the Jackson County Sports Complex Authority, expires on July 15, 1999; and,

WHEREAS, pursuant to 64.930, RSMo 1994, and case law construing said section, in the event a vacancy exists, a panel of three nominees shall be submitted by majority vote of the County Legislature to the governor for appointment; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the following nominees shall be submitted to the Governor for his consideration for final appointment to fill the vacancy on the Jackson County Sports Complex Authority occasioned by the expiration of the term of the Reverend Nelson Thompson, for a new term to expire July 15, 2003:

- A. Gloria J. Abercrombie
- B. Bennie L. Lewis
- C. Stephen T. Nelson
