WHEREAS, she also worked at the Four Winds restaurant at the old Municipal Airport for about ten years; and,

WHEREAS, Petey's hobbies include playing bridge and poker; and,

WHEREAS, Petey has one daughter, Barbara Williams, seven grandchildren and ten great-grandchildren; and,

WHEREAS, Petey will retire from the Hereford House Restaurant on April 24, 1998, one day after her 84th birthday; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the Legislature congratulates Mary "Petey" Skivers upon her retirement from the Hereford House Restaurant and wishes her success in all future endeavors.
