ORDINANCE NO. 4503, February 11, 2013

INTRODUCED BY Greg Grounds, County Legislator

WHEREAS, section 1803., Jackson County Code, 1984, relating to the Jackson County Municipal Court establishes the salary of the County Municipal Court judge at \$38,500.00; and,

WHEREAS, the Municipal Court has incurred an increased caseload over the past two years and has

collected over one million dollars in revenue each of those years; and,

WHEREAS, Ordinance 4502, dated February 11, 2013, now under consideration by the Legislature will enact an increase in this code section, in the amount of \$10,000.00; and,

WHEREAS, an appropriation is necessary to give effect to this code change and to place the necessary funds in the appropriate spending accounts; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation be and hereby is made:
