**INTRODUCED BY** Scott Burnett, County Legislator

WHEREAS, by Ordinance 4162, dated October 19, 2009, the legislature did authorize the appropriation of \$483,100.00 from the fund balance of the 2009 Grant Fund in acceptance of the Energy Efficiency Conservation Block grant awarded by the U.S. Department of Energy; and,

WHEREAS, a portion of the grant funds were designated to be used to purchase software to remotely power down computers and monitors resulting in energy savings; and,

WHEREAS, the Information Technology department recommends the software package offered by BigFix, Inc. to best meet the needs of the county in recognizing energy savings; and,

WHEREAS, the execution of this Agreement is in the best interests of the health, welfare, and safety of the citizens of Jackson County; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive be and hereby is authorized to execute an Agreement with BigFix, Inc., in a form to be approved by the County Counselor; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing be and hereby is authorized to make all payments, including final payment on the agreement.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
