ORDINANCE 2590, October 7, 1996

BE IT ORDAINED by the County Legislature of Jackson County, Missouri as follows:

Section 1. The Zoning Order of Jackson County, Missouri, and the official maps which are a part thereof, are amended by changing the boundaries of the "A" (Agricultural) District and the "GB" (General Business) District so that there will be transferred from District A to District GB a tract of land described as follows:

The 15.5 + acre tract of land is generally located at the northeast corner of Missouri 7 Highway and Wyatt Road and more specifically described as follows: The west 500 feet of the southeast quarter of the southwest quarter of Section 18, Township 48, Range 30 in Jackson
