WHEREAS, the Purchasing Director has solicited formal written bids on Bid No. 111-98 for the furnishing of group life insurance and supplemental life insurance for use county wide; and,

WHEREAS, he has received seven (7) responses from various vendors, with Trans-General Life Insurance, meeting the bid specifications of the bid order; and,

WHEREAS, the Purchasing Director and the County's Broker has recommended that award be made to Trans-General Life Insurance Company for the reason that it is the lowest and best bid as set out in the attached recapitulation and analysis; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made as recommended by the Purchasing Director and Broker, and that the Purchasing Director be, and is hereby, authorized to execute for the County any documents necessary to the accomplishment of the award; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make all payments, including final payment on the contract.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
