INTRODUCED BY Manuel Abarca IV, County Legislator

WHEREAS, taxes are assessed on personal property owned on January 1st of every year, but taxes

are not billed until November of the same year; and,
WHEREAS, taxes are due by December 31st for the entire amount assessed and billed regardless of
the ownership status of the property or if it has been moved from Jackson County; and,
WHEREAS, personal property taxes are levied annually against tangible personal and real property
and are due December 31 st of each year per Missouri state statute; and,
WHEREAS, a mid-year collection of personal property taxes would be appropriate; now therefore,
BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the Legislature does
hereby express its intent and recommendation to the Missouri State Legislature of a mid-year tax
collection date.
Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
