**A RESOLUTION** transferring \$24,998.00 within the 2023 Special Road & Bridge Fund and awarding a contract to American Equipment of Kansas City, KS, for dump truck repair for use by the Public Works Department at an actual cost to the County in the amount of \$24,998.00, as a sole source purchase.

**RESOLUTION NO. 21435**, October 16, 2023

**INTRODUCED BY** Jeanie Lauer, County Legislator

WHEREAS, the Public Works Department has a dump truck that is in need of repairs; and,

WHEREAS, the hydraulic system has malfunctioned and overheated causing the system to be inoperable; and,

WHEREAS, the dump truck is an important vehicle in the fleet and is needed in the winter season for inclement weather road remediation; and,

WHEREAS, a transfer is necessary to place the funds needed for the repairs of the dump truck in the appropriate spending account; and,

WHEREAS, pursuant to section 1030.1 of the Jackson County Code, the Directors of Finance and Purchasing and Public Works recommend the repair of the dump truck from American Equipment, Kansas City, KS, as a sole source purchase as American Equipment is the only company that provides the specialized service needed for repair of the dump truck; now therefore;

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the following transfer within the 2023 Special Road & Bridge Fund be and hereby is made:

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing is authorized to make all payments, including final payment, on the contract.
