BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the Director of the Department of Finance issue a check in the amount of \$50.00 in the names of Garry D. and Brenda C. Piatt, and that the check be delivered to the Department of Public Works, Kaye Merkle, Engineering Division, for appropriate disposition...Attorney
