WHEREAS, the Sheriff's Office has been awarded a grant in the amount of \$181,563.33 by the Missouri Department of Transportation, Highway Safety Division, for the purpose of funding a five-person Traffic Unit consisting of one sergeant and four deputies for the period of October 1, 2011 to September 30, 2012; and,

WHEREAS, during the first six months of 2011, the Traffic Unit has arrested over 97 persons for DUI, written over 3,665 tickets, and Issued 1,187 warnings; and,

WHEREAS, the grant is subject to a local match in the amount of \$181,563.33; and,

WHEREAS, the Sheriff recommends the acceptance of this grant and the execution of an agreement with the Missouri Department of Transportation, Highway Safety Division; and,

WHEREAS, a transfer and appropriation are necessary to place the grant and matching funds in the proper spending accounts; now therefore,
