ORDINANCE 3115, January 16, 2001

WHEREAS, Section 3.3 of the Series 1994 Leasehold Revenue Bond Lease Agreement between Jackson County and the Jackson County Public Facilities Authority require the Jackson County

Legislature to annually adopt an Ordinance setting forth: 1) the renewal of each Lease for an additional one-year term; and, 2) an assurance that funding for the rental payments and other additional payments has been encumbered in the County's annual budget; therefore,
BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the lease agreement between Jackson County and the Jackson County Public Facilities Authority are hereby renewed for an additional one-year term; and,
BE IT FURTHER ORDAINED that County funds have been irrevocably budgeted, appropriated, and set aside in an amount sufficient to pay the anticipated rental payments and additional payments to become due during the forthcoming renewal year.
