WHEREAS, the Director of Finance and Purchasing has solicited bids on Invitation to Bid No. 64-20 for the furnishing of inmate clothing for use by the Corrections Department for the upcoming twelve-month period, with one twelve-month option to extend; and,

WHEREAS, a total of sixty-four notifications were distributed, and eight responses were received, with five being rejected as non-responsive; and,

WHEREAS, following evaluation of the bids submitted, the Director recommends that the contract be divided and awarded to the vendors submitting the lowest bid for each item; and,

WHEREAS, award as recommended would result in awards to the following:

WHEREAS, this award is made on an as needed basis and does not obligate Jackson County to pay any specific amount, with the availability of funds for specific purchases subject to annual appropriation; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made as recommended by the Director of Finance and Purchasing, and that the Director be and hereby is authorized to execute for the County any documents necessary for the accomplishment of the award; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing be and hereby is authorized to make all payments on the contracts, including final payments, to the extent that

sufficient appropriations to the using spending agency are available in the then current Jackson County budget.
