WHEREAS, the Purchasing Director has solicited formal written bids on Bid No. 143-99 for the printing and mailing of business personal and real estate change notices for use by the Assessment Department; and,

WHEREAS, the only bid received was from Brian Pollmiller and Associates of Lenexa, KS; and,

WHEREAS, the contract also requires the successful bidder to mail the forms for which it will be reimbursed postage costs in the amount of \$24,533.40; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made as recommended by the Assessment Director, and that the Purchasing Director be, and is hereby, authorized to execute for the County any documents necessary to the accomplishment of the award; and,

BE IT FURTHER RESOLVED that the Director of the Division of Finance is authorized to make all payments, including final payment on the contract...Attorney
