AN ORDINANCE amending the districts established by the Jackson County Zoning Order by changing from A (Agricultural) to RR (Residential Ranchette), a certain 10 ± acre tract.

ORDINANCE # 3215, December 3, 2001

BE IT ORDAINED by the County Legislature of Jackson County, Missouri as follows:

<u>Section 1</u>. The Zoning Order of Jackson County, Missouri, and the official maps which are a part thereof, are amended by changing the boundaries of the "A" (Agricultural) District and the "RR" (Residential Ranchette) District so that there will be transferred from District A to District RR a tract of land described as follows:

Description: A 10 ± acre tract of land generally located at the southwest corner of Little Road and Borgman Road and more specifically described as: A Tract of land being located in the North ½ of the Southwest 1/4 of Section 6, Township 49 North, Range 29 West of the 5th P.M., Jackson County, Missouri being described as follows: Beginning at the Northeast Corner of said North ½, Southwest 1/4; thence S00°44'50"E along the East line of said North ½, Southwest 1/4, a distance of 667.27
