**A RESOLUTION** authorizing the County Executive to execute a Memorandum of Understanding with Local Union No. 42 of the International Association of Fire Fighters.

**RESOLUTION #13956**, December 17, 2001

**INTRODUCED BY** Terry Young, County Legislator

WHEREAS, by an order dated April 20, 2001, the Missouri State Board of Mediation certified Local Union No. 42 as the bargaining representative for certain assistant prosecuting attorneys within the Prosecuting Attorney's Office; and,

WHEREAS, over the past months a County negotiating team has met and conferred with a team appointed by the Union for the purpose of reaching agreement on a Memorandum of Understanding to establish wage rates, hours of work, working conditions, and procedures for settlement of differences for members of this bargaining unit; and,

WHEREAS, the County and the Union teams have concluded their negotiations and recommend approval of the Memorandum of Understanding, a copy of which is attached hereto and incorporated herein by reference; and,

WHEREAS, the Union's bargaining unit ratified this Memorandum at a meeting held on December 1, 2001; and,

WHEREAS, the approval of this Memorandum is in the best interest of the health, welfare and safety

of the citizens of Jackson County; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive be, and is hereby, authorized to execute the attached Memorandum of Understanding on behalf of the County.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
