thereof, are amended by changing the boundaries of the "AG" (Agricultural) District and the "RS" (Residential Suburban) District, so that there will be transferred from District AG to District RS, a tract of land known as 32202 E. Pink Hill Road, Grain Valley, MO, and specifically described as

Description: Lot 3, Stone Meadows, a subdivision in Jackson County, Missouri

<u>Section 2</u>. The Legislature, pursuant to the application of Jeff and Corrie Wolff, (RZ-2014-510), requesting the amendment embodied in this Ordinance and with notice that the Jackson County Plan Commission voted 7 to 0 to recommend <u>APPROVAL</u> of this application after a public hearing on October 16, 2014, does adopt this Ordinance pursuant to the Jackson County Charter authorizing the Legislature to exercise legislative power pertaining to planning and zoning.
