lowest and best proposal; and,

WHEREAS, this award is made on an as needed basis and does not obligate Jackson County to pay

any specific amount, with the availability of funds for specific purchases being subject to annual

appropriation, which is estimated for 2024 to be \$400,000.00; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made as

recommended by the Director of Finance and Purchasing, and that the Director be, and is hereby,

authorized to execute for the County any documents necessary for the accomplishment of the award;

payments, including final payment on the contract, to the extent that sufficient appropriations to the

using spending agency are contained in the then current Jackson County budget.
