WHEREAS a transfer within the 1998 Assessment Fund is necessary to cover the costs of printing of business personal property declaration forms and envelopes; and,

WHEREAS, the contract also requires the successful bidder to mail the forms, for which it will be reimbursed postage costs in the amount of \$129,978.00; therefore,
