WHEREAS, he has received as the only bid thereon a bid from Service Edge (formerly Kansas City Food Service) of Kansas City (Jackson County), MO; and,

WHEREAS, the Director of Finance and Purchasing has recommended that award be made to Service Edge (formerly Kansas City Food Service) of Kansas City, MO, for the reason that it has submitted the lowest and best bid; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made as recommended by the Director of Finance and Purchasing, and that the Director be, and is hereby, authorized to execute for the County any documents necessary to the accomplishment of the award; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make all payments, including final payment on the contract, to the extent sufficient appropriations to the using spending agency have heretofore been made in the current Jackson County budget.
