WHEREAS, the Director of Finance and Purchasing recommends the purchase of hand- held radios for use by the Drug Task Force from Motorola of Lee's Summit, MO, under the terms and conditions set forth in Johnson County, Kansas Contract No. 2007-014, an existing government contract; and,

WHEREAS, pursuant to section 1030.4, Jackson County Code, 1984, the Director of Finance and

Purchasing is required to submit any purchase under an existing government contract which exceeds \$25,000.00 to the Legislature for approval; and,

WHEREAS, the Director of Finance and Purchasing recommends the purchase from Motorola under the existing government contract, due to the higher volume discounts offered to larger entities; now therefore;

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made as recommended by the Director of Finance and Purchasing, and that the Director be and hereby is authorized to execute for the County any documents necessary to the accomplishment of the award; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing be and hereby is authorized to make all payments, including final payment on the purchase.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
