WHEREAS, the term of Georgia Buchanan, a member of the Jackson County Sports Complex Authority, expired on July 15, 2008; and,

WHEREAS, pursuant to §64.930, RSMo, 2000, and case law construing said section, in the event a vacancy exists, a panel of three names shall be submitted by majority vote of the county legislative body to the governor for appointment; and,

WHEREAS, by Resolution 16810, dated January 26, 2009, the Legislature did submit a panel to the

governor; and,

WHEREAS, Governor Jay Nixon has now requested that the Legislature submit a new panel; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the following names shall be submitted to the Governor for his consideration for final appointment to fill the vacancy on the Jackson County Sports Complex Authority occasioned by the expiration of the term of Georgia Buchanan, for a new term to expire July 15, 2013:
