WHEREAS, pursuant to Chapter 28, Jackson County Code, 1984, the City of Blue Springs, Missouri, has requested the use of \$224,411.70 from its CURS account for road improvements and maintenance within the City of Blue Springs; and,

WHEREAS, the Legislature finds that the projects proposed by the City will benefit the citizens of Blue Springs and the citizens of Jackson County; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that pursuant to Chapter 28, Jackson County Code, 1984, the Director of the Department of Finance is authorized to issue a check in the amount of \$224,411.70 to the City of Blue Springs.
