WHEREAS, the COMBAT Administration recommends that \$46,704.00 in Anti-Drug Sales Tax Funds be allocated to the Sheriff's Office's 2011 Drug Abuse Resistance Education (DARE) program representing one-half of the 2011 allocation for DARE, with the balance to be transferred mid-year subject to available revenues; and,
