WHEREAS, the attached Agreement for Environmental Services provides a suitable mechanism by which to implement the agreement and understanding of the parties; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive be and hereby is authorized to execute the attached Agreement for Environmental Services with the City of Raytown, Missouri.
