INTRODUCED BY John C. Graham, County Legislator

WHEREAS, it has become necessary, in connection with the Fields Road Bridge Improvement, Project No. 2314, to acquire a permanent drainage easement over, and to cause certain damage to, the property of a certain property owner, James A. Shotton, in the amount of \$2,270.00, said property being more fully described in the conveyance instrument, a copy of which is attached hereto and incorporated herein by reference; and,

WHEREAS, the owner has agreed to convey said permanent drainage easement, and to settle the claim for damages and has executed this conveyance in favor of the County in consideration of the total payment of \$2,270.00; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the Director of the Department of Finance issue a check in the amount of \$2,270.00 in the name of James A. Shotton, and that the check be delivered to the Department of Public Works, c/o Kaye Merkle, Engineering Division, for appropriate disposition...Attorney
