WHEREAS, the Director of the Recorder of Deeds Department recommends a Cooperative Agreement with the Jackson County Historical Society for professional archiving services for the File #: 21341, Version: 0 period of January 1, 2023, through December 31, 2023; and, WHEREAS, the Jackson County Historical Society has the expertise to provide such professional archiving services; now therefore, BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive be, and hereby is, authorized to execute the attached Cooperative Agreement with the Jackson County Historical Society for professional archiving services, at an actual cost to the County in the amount of \$36,000.00; and, BE IT FURTHER RESOLVED that the Director of Finance and Purchasing is authorized to make all payments, including final payment, on the agreement. ..Enacted and Approved Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
