WHEREAS, the Purchasing Director has solicited formal written bids on Bid No. 44-99 for the repair, inspection, and service of the County's fire pump and sprinkler system for use by the Facilities Management Department to provide for its needs for the upcoming one-year period; and,

WHEREAS, the Purchasing Director has received as the three lowest bids thereon, bids from the following:

VENDOR	BID
Armor Fire Protection Lenexa, KS	low bid
Firemaster Kansas City (Jackson Co.), MO	38% higher
National Fire Suppression Kansas City, KS	50% higher

and,

WHEREAS, the Purchasing Director has recommended that award be made to Armor Fire Protection of Lenexa, KS, for the reason that it has submitted the lowest and best bid as set forth in the attached analysis; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made as recommended by the Purchasing Director, and that the Purchasing Director be, and is hereby, authorized to execute for the County any documents necessary to the accomplishment of the award; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make all payments, including final payment on the contract, to the extent sufficient appropriations to the using spending agency have heretofore been made in the current Jackson County budget.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
