RESOLUTION # 10250, March 21, 1994

INTRODUCED BY Silvia A. Rizzo, County Legislator

WHEREAS, the voters of Jackson County, Missouri, approved imposition of a sales tax for seven years to provide funding for the fight against illegal drugs in our community; and,

WHEREAS, the Legislature authorized a Grant Match Fund through Ordinance #2214; and,

WHEREAS, The Curators of the University of Missouri, at Kansas City, need a local match in the amount of \$150,000 to receive federal funds in the amount of \$483,799; and,

WHEREAS, this is the first year for this grant program; and,

WHEREAS, the Fiscal Commission has reviewed this grant application and recommends funding in the amount of \$150,000; therefore, BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the Chair of the Fiscal Commission is hereby authorized to execute the attached Agreement with The Curators of the University of Missouri, at Kansas City; and,

BE IT FURTHER RESOLVED that the Manager of the Division of Finance is hereby authorized to make all payments, including final payments on this Agreement.
