AN ORDINANCE amending the zoning districts established by the Jackson County Zoning Order by changing from A (Agricultural) to RS (Residential Suburban), a certain 1.0 ± acre tract.

ORDINANCE # 3264, June 10, 2002

BE IT ORDAINED by the County Legislature of Jackson County, Missouri as follows:

<u>Section 1</u>. The Zoning Order of Jackson County, Missouri, and the official maps which are a part thereof, are amended by changing the boundaries of the "A" (Agricultural) District and the "RS" (Residential Suburban) District so that there will be transferred from District A to District RS a tract of land described as follows:

Description: A 1 ± acre lot generally located south of 130th Street on the east side of 130th Terrace and is legally described as Lot 21, Trophy Estates, a subdivision lying in the southeast quarter of Section 13, Township 47, Range 31 in Jackson County, Missouri aka 25304 E. 130th Terrace.
