WHEREAS, by Resolution 14708, dated September 9, 2003, the Legislature approved a term and supply contract with Truman Medical Center of Kansas City, MO, for the furnishing of X-ray services for use by the Medical Examiner's Office, at an estimated cost to the County of \$25,000.00; and,

WHEREAS, it is necessary to increase this contract in the amount of \$40,000.00 due to a higher volume of usage than originally estimated; and,

contract be made as recommended by the Purchasing Director, and that the Purchasing Director be,

of the increase; and,
BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make
all payments, including final payment on the contract, to the extent sufficient appropriations to the
