RESOLUTION #12384, October 5, 1998

INTRODUCED BY John C. Graham, County Legislator

WHEREAS, the County did, by Resolution 11808, dated June 23, 1998, enter into a contract with Superior-Bowen Asphalt Company of Kansas City, MO, in the amount of \$1,342,716.10, for the 1995 Road Surface Rehabilitation Project, No. 2320; and,

WHEREAS, subsequent change orders have adjusted the contract amount to the current authorization of \$1,358,332.16; and,

WHEREAS, the proposed Change Order No. 3 (Final), a copy of which is attached hereto and incorporated herein by reference, is necessary to adjust all plan quantities to as-built quantities, and said change order will result in a decrease of \$11,193.84 in the contract amount; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that Change Order No. 3 to the aforesaid contract is approved and the County Executive is authorized to execute the change order on behalf of the County; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make all payments, including final payment on the contract... Attorney
