**ORDINANCE # 3248**, April 15, 2002

**INTRODUCED BY** Terry Young, County Legislator

WHEREAS, by Resolution 13991, dated January 28, 2002, the Legislature did authorize an agreement with the Cabot Westside Clinic to provide a variety of health care and social welfare services to the indigent residents of the Westside of Kansas City, Missouri, at a cost to the County not to exceed \$45,000.00; and,

WHEREAS, the Legislature now desires to increase the funding allocated to this agency to bring that funding up to the level allocated in previous years; and,

WHEREAS, the attached Addendum to Agreement provides a suitable mechanism by which to provide this increased funding; and,

WHEREAS, in order to provide this increased funding, an appropriation is necessary; and,  
WHEREAS, the County Executive recommends this appropriation as an amendment to her proposed annual County budget; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation be and hereby is made:
