WHEREAS, the Director of Finance and Purchasing recommends the award of a one-year contract with annual renewal options for five additional years for the furnishing of health insurance as an employee benefit for use countywide to Blue Cross Blue Shield of Kansas City, MO, under the terms and conditions of Request For Proposal No. 39-08 as the lowest and best bid, at an estimated first year cost to the County of \$[10,055,859.12] 10,056,056.04; and,

WHEREAS, this award is made on an as needed basis and does not obligate Jackson County to pay any specific amount, with the availability of funds subject to annual appropriation; and,
