A RESOLUTION authorizing the County Executive to execute an agreement with Children's Mercy Hospital for the continuation of the Family Friends - Healthy Tomorrows program in the amount of \$40,000.
RESOLUTION # 11994, December 15, 1997

INTRODUCED BY Dennis Waits, County Legislator

WHEREAS, the Prosecuting Attorney was empowered by §9307., Jackson County Code, 1984, to make recommendations to the Legislature for the expenditure of Anti-Drug Sales Tax Funds to match grants from governmental and private sources for the purposes of treatment and rehabilitation of drug offenders and the prevention of drug offenses; and,

WHEREAS, the Prosecuting Attorney has reviewed a proposal from Children's Mercy Hospital for its Family Friends - Healthy Tomorrows program; and,

WHEREAS, the Family Friends - Healthy Tomorrows program is a inter-generational model whereby trained volunteers provide a role model for parents through peer support in the critical post treatment stage through visits with the family and children; and,

WHEREAS, this program is an effort which includes information on accessing other community support organizations; and,

WHEREAS, Family Friends - Healthy Tomorrows staff provide direct services in supportive counseling, and parenting education through in-home weekly visits for at least four hours; and,

WHEREAS, the Family Friends - Healthy Tomorrows program receives federal funding from the Department of Health and Human Services in the amount of \$50,000; and,

WHEREAS, the Prosecuting Attorney has carefully reviewed this proposal from Children's Mercy Hospital; and,

WHEREAS, the Prosecuting Attorney has recommended funding in the amount of \$40,000 from the grant match account for the Family Friends - Healthy Tomorrows proposal; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive is hereby authorized to execute an agreement, in a form to be approved by the County Counselor, with Children's Mercy Hospital for the Family Friends - Healthy Tomorrows program; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance be and hereby is authorized to make all payments, including final payment on the Agreement...Attorney

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
