surplus for unexpected or additional expenses on the property around and adjacent to Aquila's Prairie

temporary construction easement, further described in the attached exhibit "A", be and hereby is
accepted and that the Manager of Finance be and hereby is directed to issue a lump sum payment in
the amount of \$10,000.00 to Aquila Inc., in consideration for said easement.
