INTRODUCED BY Dennis Waits and Scott Burnett, County Legislators

WHEREAS, the Office of the Prosecuting Attorney has solicited informal bid proposals from internet website development companies for the development and maintenance of a website separate from the Jackson County website fro the Office of the Prosecuting Attorney; and,

WHEREAS, the proposed website would also serve as a connection with the Jackson County COMBAT Commission and Anti-Drug Unit of the Jackson County Prosecuting Attorney's office; and,

WHEREAS, the Office of the Prosecuting Attorney has recommended a proposal made by Bensoft Incorporated, a copy of which is attached hereto as Exhibit "A", for development and maintenance of a website from January 1, 2005 through December 31, 2005 at a cost to the County not to exceed \$25,000 with monthly payments due upon invoice; and,

WHEREAS, the Jackson County Prosecutor recommends payment for these services from the Anti-Drug Sales Tax Fund; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, authorizes the County Executive to execute an agreement in a form to be approved by the County Counselor incorporating recommended proposal; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make all payments, including final payment on the contract.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
