appropriation; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made under

the existing competitively bid contract as recommended by the Director of Finance and Purchasing

and that the Director be, and hereby is, authorized to execute for the County any documents

necessary for the accomplishment of the award; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing is authorized to make all

payments, including final payment on the contract, to the extent that sufficient appropriations to the

using spending agencies are contained in the then current Jackson County budget.
