Land Use Committee Amendment June 10, 1996

IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

AN ORDINANCE amending the districts established by the Jackson County Zoning Order by changing from A (Agricultural) to RR (Residential Ranchette), a certain 33.4 + acre tract and approving the preliminary plat "Breezy Meadows," creating a six- lot residential subdivision.

ORDINANCE 2541, June 3, 1996

INTRODUCED BY Fred Arbanas, County Legislator

BE IT ORDAINED by the County Legislature of Jackson County, Missouri as follows:

Section 1. The Zoning Order of Jackson County, Missouri, and the official maps which are a part thereof, are amended by changing the boundaries of the "A" (Agricultural) District and the "RR" (Residential Ranchette) District so that there will be transferred from District A to District RR a tract of land described as follows:

A 33.4 + acre tract of land generally located 1/2 mile south of Hendricks Road on the west side of Bynum Road (State Hwy. V-V), more specifically described as the east 870 feet of the south 48 acres of the southeast Quarter of Section 25, Township 47, Range 30 and the
