A RESOLUTION authorizing the County Executive to execute a permanent utility easement in favor of the Kansas City, Missouri Water Department across a portion of the Rock Island Corridor, for a fee payable to the County.

RESOLUTION NO. 21530, February 19, 2024

INTRODUCED BY Charlie Franklin, County Legislator

WHEREAS, the City of Kansas City, Missouri Water Department is requesting a permanent water line utility easement of 6,245 square feet across a portion of the Rock Island Corridor; and,

WHEREAS, the Parks + Rec Department has determined that the permanent water line utility easement will have no adverse effect on the use of the corridor; and,

WHEREAS, the City of Kansas City will pay the County the sum of \$3,249.00 for the easement which includes the \$2,000.00 administrative fee and .20/square foot easement fee of \$1,249.00; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, the permanent utility easement is hereby approved, and that the County Executive is hereby authorized to execute the easement on behalf of the County.
