WHEREAS, Keep Kansas City Beautiful provides public awareness, educational curricula, and litter

WHEREAS, Jackson County has adopted the slogan "Jackson County-too beautiful to waste" and desires to be named as a leader, participant and supporter of Keep Kansas City Beautiful and to encourage its residents to support litter abatement and beautification efforts made available through Keep Kansas City Beautiful; and,
WHEREAS, the attached agreement provides a suitable mechanism by which to implement the County's assistance to Keep Kansas City Beautiful; now therefore,
BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive be and hereby is authorized to execute the attached agreement with Keep Kansas City Beautiful; and,
BE IT FURTHER RESOLVED that the Manager of the Division of Finance be and hereby is authorized to make all payments, including final payment on the agreement.
