WHEREAS, the City of Greenwood, Missouri, has requested the use of \$12,032.76 from its CURS refund account to cover maintenance costs for its 2000 street and road maintenance program; and,

WHEREAS, the Legislature finds that the street and road maintenance project proposed by the City will benefit the citizens of Greenwood and the citizens of Jackson County; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that pursuant to Chapter 28, Jackson County Code, 1984, the Director of the Department of Finance is authorized to issue a check in the amount of \$12,032.76 to the City of Greenwood for use in the City's 2000 street and road maintenance program.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
