WHEREAS, the County pursuant to an Intergovernmental Cooperative Agreement with the City of Kansas City, Missouri utilizing CURS monies, as right-of-way agent for the City, is in the process of acquiring right-of-way for 85th and Troost Road Improvements, Project No. 2407; and,

WHEREAS, D & H Enterprises, Inc. the owner of property identified as project tract No. 85-34 (tax

parcel 48-210-16-01) agreed to convey the necessary right-of-way by warranty deed to the City of
Kansas City, Missouri for the sum of \$600,000.00 as set forth in Exhibit "A"; and,
WHEREAS, the City and the Director of the Department of Public Works recommend the use of
CURS monies to accomplish this purchase as part of the Project No. 2407; and,
WHEREAS, the Director of the Department of Public Works recommends the payment of
\$600,000.00, to be paid to D & H Enterprises, Inc. as a one time lump sum; now therefore,
BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the Manager of
Finance be and hereby is directed to issue a lump sum payment in the amount of \$600,000.00 to D $\&$
H Enterprises, Inc. in consideration for said conveyance.
